The Downeast National Juried SculptureExhibition is located in Greenville, North Carolina. The Downeast Outdoor Sculpture Exhibition is a jo intexhibition among Pitt County Arts Council at Emerge, ECU Visual Arts Committee, City of Greenville, Town of Winterville, Pitt Community College, and the Greenville Museum of Art It includes both a month long indoor exhibition and a year long outdoor exhibition.

meet the juror

A N orth C arolina native, Kyle Van Lusk studied at Brevard College and East Ca rolina Uni versity, graduating from ECU in 1995 with a BFA in sculpture. Lusk's work has been exhibited in numerous public exhibitions and featured in many public, as well as priv ate, collections including Public Art Ch attanooga, Be ber Sculpture Garden at Duke University, and Creative Arts Guild Sculpture Park in Dalton GA. Lusk continues to create public sculpture and currently serves as the coordinator of the Art major at Brevard College in Brevard NC where he lives with his wife, Heidi, and three children.

INDOOR EXHIBITION

eligibility

This exhibition is open to all artists ages 18 and up. Any three dimensional media is eligible. Inside submissions must fit through a standard size door. Work must be ready to display. All entries must be submitted digitally.

dropoff & pi ckup

Accepted indoor work must be dropped off or received by Saturday, Feb. 25 th, between 10 AM and 2PM, to Emerge Gallery located at 404 S. E vans Street, Gre enville, NC 27858. Accepted indoor work must be pi cked up at the conclusion of the exhibition on Saturday, April 1 st, between 10 AM and 2PM. Work left after the exhibition will become the property of Emerge Gallery.

prizes

\$5 00 - 1 st Place \$2 50 - 2nd Place \$1 00 - 3rd Place

insurance

Pitt County Arts Council at Emerge will provide insurance for accepted indoor work from the dropoff dates through the last day of the exhibition. Work will not be insured after April 1, 2017. Work will be insured only for 60 percent of the sales price. Insurance value mustbe are alistic value and may be questioned. Proof of similar sales will be requested, if necessary. Consent to reproduce for publicity, catalog, or e ducational purposes is assumed unless specifically reserved in writing. Submission of entry constitutes agreement to all conditions.

OUTDOOR EXHIBITION

eligibility

This exhibition is open to all artists ages 18 and up. All entries must be submitted digitally. Work should be large scale to fit one of the 10 sculpture pads in various locations. Sculpture pads range from 4'x5' to 10' in diameter. A rtists must be available to install and un-install their own work. They may have some help from the entity where the sculpture is placed. Liability insurance may be asked for in the City of Gre enville's location. All work must remain on exhibit from the end of February 2017 through the end of Fe bruary 2018. Work must be able to be exhibited outdoors and utilize materials that are exterior grade.

dropoff & pickup

Installation and uninstallation of accepted work will be coordinated by the exhibiting entities. Aid with installation may be offered by the exhibiting entity, but liability and arts insurance will not be cove red until after installation and before uninstallation. Contracts for a one year term will be conducted with each entity and the chosen artist typically for one year from the last week in February 20 17 until the last week in February 2018.

prizes

There will be 10 honorariums awa rded of \$1,000 each. Additional prizes include 1st place: \$1,500

2nd place : \$750 3rd place : \$500

insurance

Work will be insured by the presenting entity except the C ity of Gre enville. Liability insurance is required by the C ity of Gre enville's site; however, the other sites will be covered by the presenting entity. There are 10 sculpture pads total within PittC ounty. Work will be insured only for 60 percent of the sales price and only for the exhibition dates (does not include installation and uninstallation.) Insurance value must be a realistic value and may be questioned. Proof of similar sales will be asked for if necessary. C onsent to reproduce for publicity, catalog, or e ducational purposes is assumed, unless specifically reserved in writing. Su bmission of entry constitutes agreement to all conditions.

sales & commission

It is assumed that all work is for sale unless noted with an insurance value. Emerge Galle ry will retain a 40 percent commission (30 percent for ECU students.) If work is not for sale, an insurance value must be given and NFS stated or work will not be insured. Payment will be mailed for sold work within 45 days.

entries & fees

Each a rtist may submit up to 3 entries (indoor and outdoor combined) for the total of \$15. Additional entries cost \$5 per entry with a limit of 6 total entries. Checks should be payable to "PCAC at Emerge." All entries must be submitted digitally and received by Sat, Jan. 21, 2017. Images of work may be submitted as jpgs on a CD, flash drive, or e-mailed to info@pittcountyarts.org. Payment and registration can be submitted online at www.pittcountyarts.org or mailed/delivered to Emerge Galle ry.
