Holiday Sale

There are two options for artist booths this year.

Option 1: Artists may apply for a booth space in which they have to be present on Thursday, December 1 from 5 - 8 p.m. for the ticketed preview event "Crafted" and on Friday, December 2 from 5 - 8 p.m. during the First Friday Artwalk. Artists retain 100% of their sales during these two events and during the remainder of the sale, artists will sell on a commission basis (60% artist/ 40% gallery).

Option 2:

Artists may apply for a booth space in which they do not have to be present for events, but will sell on a commission basis (60% artist/40% gallery).

Terms and Conditions

- The market is open to all fine arts and crafts and holds 12 tables.
- During the 2 day period in which Option 1 artists must be present, artist retains 100% of sales. After required two days, all sales are run on normal commission (40% for Emerge and 60% for artist.)
- During the two day period of required presence, if you need sales run through our credit card and sales system, this will be done on normal commission basis (40% for Emerge and 60% for the artist.) Artists who have their own credit card machines will not be affected. Due to fees, staffing, and the inability to separate the sales from these three days from the remaining commission days, this is a necessary policy for our organization.
- Option 1 artists are responsible for monitoring their own sales.
- Option 2 artists set up a booth space and all sales are run on normal commission (40% for Emerge and 60% for the artist).
- Any sales made through Emerge during Holiday Artist Market will be paid by January 15th.
- Booth spaces will be available in both of our main gallery spaces: The Edwards Gallery and the Wooten Gallery. Due to the size and shape of the gallery spaces, an exact dimension is not determined for a booth space. Artists will be given adequate space to fit their need not exceeding 50 sq. ft.
- Only 1 artist/business per booth. We do not allow the transfer of booths.
- Electricity is available upon request.
- Work will be insured beginning from December 1 - 18, 2016.
- Booth set up materials are to be provided by artist. Emerge does have tables for rent for an additional fee.

Fees

- A non-refundable application fee of \$15 must be submitted along with the application and up to five images of work. These are required of all artists and will be used for promotional materials. They need to be professional in appearance and sized at 300dpi.
- Application deadline is Friday, October 23rd
Applicants will be notified of acceptance within 1 week of receipt of their application.
- Artists may apply and pay their fees online at www.pittcountyarts.org or in person at our facility.
- Application fee and booth fee are required at time of application. In the case that an artist is not accepted, booth fees will be refunded within 15 days.
- Artists will provide their own table or rent one from Emerge. Table fees: 5' and 6' are \$15. 8' are \$25.
